Subject: Extension of 2017 Agreement for Services between Arapahoe County and G4S Secure Solutions USA, Inc. per RFP-17-38

Request and Recommendation

Request the Board of County Commissioners to authorize the Arapahoe County Sheriff to sign the extension to the Agreement for Services between Arapahoe County and G4S Secure Solutions USA, Inc. (G4S) for the provision of armed security services for Arapahoe County Facilities, as well as any subsequent amendments or extensions thereto.

Background

An RFP for armed security services for Arapahoe County facilities was solicited in 2017 with the option to renew the contract for subsequent one-year periods. The optional renewal periods shall not exceed a total of three additional years.

Optimize Use of Resources: The RFP process ensures that the Arapahoe County Sheriff's Office Detention Facility is getting the best possible price for the services it needs.

Discussion

G4S was awarded the contract for the provision of armed security services for Arapahoe County facilities per RFP-17-38, with the option to extend the contract for up to three subsequent one-year periods. Prior to signatures, each extension will go through the Contract Management System, including approvals from the Budget Division reviewing for available dollars in the department budget, the Purchasing Manager reviewing to make sure the purchasing process was followed, Risk Management reviewing for insurance requirements, and the County Attorney reviewing for any legal issues.

Alternatives

There is no alternative as G4S was awarded the contract per formal solicitation.

Fiscal Impact

The cost of the Agreement for Services is funded through the General Fund budget. G4S requested an increase but their request was denied as it was not in accordance with the 2018 Consumer Price Index. The 2018-2019 contract rates will be the same as the 2017-2018 rates.
