Visitation Center Rules and Regulations

ALL VISITS ARE MONITORED AND RECORDED

On-site visitation is permitted during these hours:
Wednesdays 6:30 p.m. to 9:00 p.m.
Sundays 9:00 a.m. to 4:00 p.m.

Inmates are permitted to visit only during listed on-site visitation hours. Visits scheduled during unauthorized hours or that conflict with other scheduled events will be cancelled. Inmate workers will not receive visits during their work assignment. It is the duty of the inmate to check his visitation schedule.

Rules & Regulations for all On-site Visitors:

- All visitors are required to register and schedule visits through the Securus website at www.securustech.net at least 48 hours prior to date and time requested.
- No loitering in the visitation center, only pre-approved scheduled visitors may enter the visitation center.
- All visitors must check in 10 minutes prior to the scheduled visit. Visitors and guests over the age of 18 must present a valid government-issued photo I.D.
- A maximum of two (2) visitors are permitted per visitation session
- Visitors and guests may only visit once per day.
- Inmates may only have 2 scheduled visits per week (Wednesday and/or Sunday).
- Visits are thirty (30) minutes in length. Late arrivals will be allowed the remainder of the scheduled visitation period; no time extensions are allowed.
- Visitors under the age of 18 must be accompanied by an adult. Children must be under constant, direct, adult supervision at all times while at our facility. Any unattended children will cause the visit to be terminated.
- Any person(s) using profane language, causing a disturbance, dressed inappropriately or offensively, or displaying any type of nudity will not be allowed to visit and will be required to vacate the premises.
- Use of cell phones or other electronic equipment is prohibited.
- No food or beverages are permitted in the visitation booth.
- No weapons of any type are permitted.
- Visitors or guests may be subject to prosecution if they:
 - are suspected to be, or are under the influence of drugs or alcohol, or are in possession of such items;
 - are found in violation of a court; and/or
 - are caught tampering or damaging any of the video visitation equipment.
- Visitors are required to follow the directives of staff compliantly and immediately. Visitors will be restricted due to inappropriate behavior toward staff.

The Arapahoe County Detention Facility's schedule, safety, and security are the chief priority. Scheduled visitation appointments may be changed or cancelled at any time to accommodate the needs of the Facility.

ANYWHERE VISITS:

- All visitors are required to register and schedule visits through the Securus website at www.securustech.net at least 48 hours prior to date and time requested
- Inmates are allowed unlimited Remote Visits per week as scheduling permits.
- Inmate availability is based on housing unit rules and/or disciplinary status.
- Inmates are responsible for checking the daily visitation schedules and arriving for their visitation appointments on time.
- Visiting may be canceled at any time. A credit voucher may be issued for unforeseen circumstances that result in the cancelation of a remote visit by the facility.
- Once a visit has started and is canceled or terminated by the facility for failure to comply with visiting rules, a credit voucher **will not be issued.**
- Shirt, pants, and shoes are required by inmate.
- Visitors dressed in suggestive or revealing clothing will have visit canceled and no refund.
- No cleavage showing or see through tops.
- No Spaghetti strap, tank tops, or strapless tops.
- No unauthorized persons at the monitors.
- Flashing of body parts is NOT allowed.
- Name and Date of Birth must match our records.
- The Arapahoe County Detention Facility reserves the right to deny, cancel or terminate a video visit prior to or during a video session based upon visitor or resident inmate misconduct. The Arapahoe County Detention Facility also reserves the right to restrict a visitor from participating in future use of the system.
- The cost is \$8.99 per 30-minute visit.
