Dear Ms. Hammer,

I am writing to ask that you please oppose the proposed Xcel plan to build a natural gas pipeline through the state habitat conservation area of Cherry Creek State Park.

This land is home to a number of wildlife species, including large numbers of prairie dog colonies. From an ecologic standpoint, prairie dogs are a keystone species, providing a variety of important ecological functions including soil aeration which helps plants grow, maintaining an important predator-prey relationship with other animals, and maintaining meadow ecosystems.

Such a pipeline will severely impact and harm the countless prairie dog families living in this area. Prairie dogs are sentient and highly social creatures, who are extremely family oriented (even creating special nursery chambers for their children). Those prairie dogs who are raised domestically as pets are well known for close bonding, snuggling and playful activity. In short, these are social creatures who feel pain and express emotion. A pipeline through their habitat will have significant impact on their safety and on their social structure – both during the construction process itself, as well as in the aftermath.

I am deeply troubled at the thought of the harm that will come to the prairie dog families living in Cherry Creek State Park if the Southeast Metro Natural Gas pipeline is constructed, and I implore you to object this proposal.
